there are risks associated with participating in dance. My participation and that of my dependent is completely voluntary, and by participating I am assuming on behalf of my dependent and on my own behalf (and on behalf of my successors, heirs, assigns, executors, representatives and administrators) all risks of accident, injury, illness and death which may occur during, or as a result of, participating in this Event. "Event" is hereby defined as any and all performances and practices related to Thrill The World that occur at any venue which includes, without limitation, Santa Barbara Dance Center, Santa Barbara Courthouse Sunken Gardens, Santa Barbara Alameda Park, Ojai Libby Park, Hamsa Studio, YMCA (Channel Islands' branches), Santa Ynez Valley parks, wineries, Neverland, etc (the "Venue").

I agree on behalf of my dependent and on my own behalf (and on behalf of my successors, heirs, assigns, executors, representatives and administrators) to (a) release, indemnify and discharge Ines Markelle, Thrill the World, INESSENS, "THRILL THE WORLD – Santa Barbara," Janet Reineck, World Dance for Humanity, Inc. ("World Dance"), and the Venue, including the respective owners, organizers, directors, agents, employees, independent contractors, instructors, volunteers or legal representatives thereof (collectively, the "Indemnitees") from any and all claims and causes of action (known or unknown) including, without limitation, attorneys fees and costs brought against the Indemnitees, or any of them, by any party arising out of my actions or the actions of my dependent including my or his/her negligence, while at the Event; and (b) that none of the Indemnitees is responsible for any damage to, loss or theft of my or my dependent's personal articles or property.

**PHOTO RELEASE:** I consent for my or my dependent's image and likeness to be photographed, filmed or videotaped at an Event (collectively, the "Photos") which Photos I acknowledge and agree are the property of World Dance and may be used for any legal purpose without further compensation required.

**GROUNDS FOR DISMISSAL:** In an effort to maintain a safe environment for all participants, staff, employees, volunteers and the media present at an Event, I acknowledge and agree that World Dance reserves the right to dismiss without cause and remove from the Venue any participant (including me or my dependent) in World Dance's sole discretion who fails to follow the Event or Venue rules and regulations, who causes a nuisance or a disturbance, or whose actions may endanger any person. I agree that I and my dependent shall act at all times during the Event in a safe and appropriate manner.

**NO ALCOHOL:** I acknowledge and agree that (a) the use of alcohol or illegal substances before or during any Event is prohibited and will result in dismissal from the Venue, (b) this includes NO WINE TASTING during an Event at Santa Ynez Valley wineries, (c) the purpose of the Event at Santa Ynez wineries is to dance, not to taste, and (d) this also means no possession of alcohol in the vans that may be provided by World Dance for transport to/from/in Santa Ynez Valley.
